



Terms & Conditions

Puerto Rico Sailing Trips (PRST)

Age Limitations:

- We accept customers between 4 and 85 years of age in our Janise Sailing Day and Sunset Charters aboard our 38' catamaran.
- We accept customers between 8 and 68 years of age in our Why Knot Private Sailing Day Charter aboard our 35' sailboat.
- Infants between 1 and 3 years of age will NOT be accepted in any of our charters.
- Children under 18 must be accompanied by a participating adult (21 or over) who can sign a liability waiver for the minor in the presence of a PRST authorized representative. All customers must fill out a waiver and medical questionnaire on the day of the activity.
- An adult must sign the release form for a minor under 18 years of age in presence of a PRST representative.

- An adult must accompany a minor of 18 years of age or under in order to participate in the charter.
- Children and adults pay the same price.

COVID Safety Protocols:

- For safety reasons we accept a maximum of 6 guests in our Janise Sailing Charters and a maximum of 4 guests in our Why Knot Private Sailing Day Charter to be in compliance with our COVID Safety Protocols and USCG boat permits.
- Guests over 12 years of age must show proof that they are fully vaccinated against Covid. Children under 12 years of age must present proof of a negative Covid test. Please send copy of vaccination cards and/or negative tests of the guests in your group via email to info@puertoricosailingtrips.com. To make the check-in process more efficient we request the documentation prior to the charter. We will also accept copy of your vaccination card or negative tests the day of the charter.
- Customers are required to use their face masks during the charter only if they go inside the cabin or to the bathroom.
- It is recommended to our customers and crew to clean their hands frequently and wash for at least 20 seconds.
- The frequent use of hand sanitizer is recommended for our customers and crew.

Cancellation Policy:

- If the customer cancels less than 5 days (120 hours) before the charter, the customer gets charged the full amount. If the customer cancels 5 days (120 hours) or more before the charter, the customer gets charged 20% of the total amount.
- Cancellation notices MUST be made by email.
- If PRST cancels the charter, the customer receives a full refund.
- If a customer requests a rebooking of the charter for another date or session, and the requested charter is available, the group will be charged \$80.00 per person. If the requested charter is not available we will not provide any refunds. We cannot guarantee availabilities for a requested charter rebooking.
- No refunds or credits will be issued for no-shows on the day of the charter.
- PRST reserves the right to cancel a charter if the minimum amount of participants is not completed 24 hours before the charter or for safety reasons. Should this be necessary the customer will receive a full refund or credit.

Important Notes:

- Our charter is not a party boat.
- The customers are required to follow the instructions of our crew with the purpose of fulfilling the navigation in a safe manner.
- If you are not on board by the departure time we won't wait for you or your group. This applies if your group is the only one on board or if there are other guests on board.
- If you are late to the day charter we will not delay the return time.
- If you decide to bring your own food and/or beverages please specify what you are bringing.
- If bringing your own food please make sure it is fully cooked (take-out food) and does not require us to cook it or warm it up.
- Beverages offered are not unlimited.
- For safety reasons, alcohol consumption in the boat is only allowed after we reach our destination.
- Consumption of alcohol is not allowed while sailing or motoring.
- Smoking tobacco, cigarettes or hookah is not allowed in our vessels.
- Puerto Rico Sailing Trips does not allow any type of cannabis or drugs onboard our Certified Drug Free Vessel as the United States Coast Guard (USCG) does not recognize recreational drugs, medicinal cannabis or controlled substances. Failure to follow our rules will be a reason to cancel the charter and return to the marina. No refunds or credits will be issued for the cancelled charter.

- Nudity is not allowed in the vessel or at the beaches we visit.
- Seeing wildlife in our charters is not guaranteed.
- Charters are not canceled due to rain.
- No refunds will apply if the guests decide to go back earlier to the marina because of the rain or any other weather conditions.
- There are no refunds if a guest does not feel good, gets seasick or for any other reason and wants to return back to the marina.
- Regular candles, sparkling candles or any other kind of candles are not allowed in our vessels.
- Beach spots access are not guaranteed due to weather conditions, sea weed accumulation and space availability in the anchorages.
- Snorkeling is not guaranteed and it depends on the following factors:
 - Conditions of the sea
 - Direction of the wind
 - Underwater visibility
 - Seaweed and sargassum accumulation
 - Mooring and anchoring availability
 - Swimming skills
- Children 12 years of age or younger must wear a life vest at all times during the charter.
- Dinghy use is not permitted to ferry passengers to the beach or elsewhere.

- No vulgar, or offensive music will be allowed to be played in our Bluetooth.
- We only accept guests 230 lbs or less in our Why Knot Private Sailing Charter.
- When booking your Why Knot Private Sailing Day Charter online please indicate the amount of guests so we can coordinate accordingly. The maximum amount of guests allowed is 4.
- The Why Knot Private Sailing Day Charter is always private for groups of 1 to 4 guests maximum.
- Please be advised that the Janise Sailing Day Charter is not private unless the customer paid for 6 guests or paid extra to make it private. Please notify our office if you want a private Janise Sailing Day Charter.
